

THE UNDERSIGNED OWNERS OF THE TRACT OF LAND HEREON PLATTED AND FURTHER DESCRIBED IN THE FOREGOING SURVEYORS CERTIFICATE HAVE CAUSED THE SAME TO BE SURVEYED AND SUBDIVIDED IN THE MANNER SHOWN ON THIS PLAT WHICH SHALL HEREAFTER BE KNOWN AS "GOOSE CREEK PLAT 34". STREETS SHOWN TOGETHER WITH ALL WALKWAY EASEMENTS ARE HEREBY DEDICATED TO PUBLIC USE FOREVER AND MAY BE USED FOR THAT PURPOSE AS THEIR NEED MAY REQUIRE.

ALL PROPERTY IN THIS SUBDIVISION SHALL BE SUBJECT TO THE PROTECTING COVENANTS RECORDED IN BOOK 506 PAGE 241 OF THE LAND RECORDS OF ST. FRANCOIS COUNTY, MISSOURI.
A FOUR (4) FOOT WIDE EASEMENT, TWO (2) FEET ON EACH SIDE OVER EACH OF ALL LOT LINES, STREETS AND OBSTRUCTIONS TO SURVEY INSTRUMENT SET-UP OR LINE OF SIGHT ON SAID LINES MAY BE REMOVED BY A REGISTERED LAND SURVEYOR OR HIS ASSIGNS IN THE EXECUTION OF A SURVEY WHICH HAS BEEN REQUESTED BY ANY LOT OWNER AS THEIR NEEDS MAY REQUIRE.
