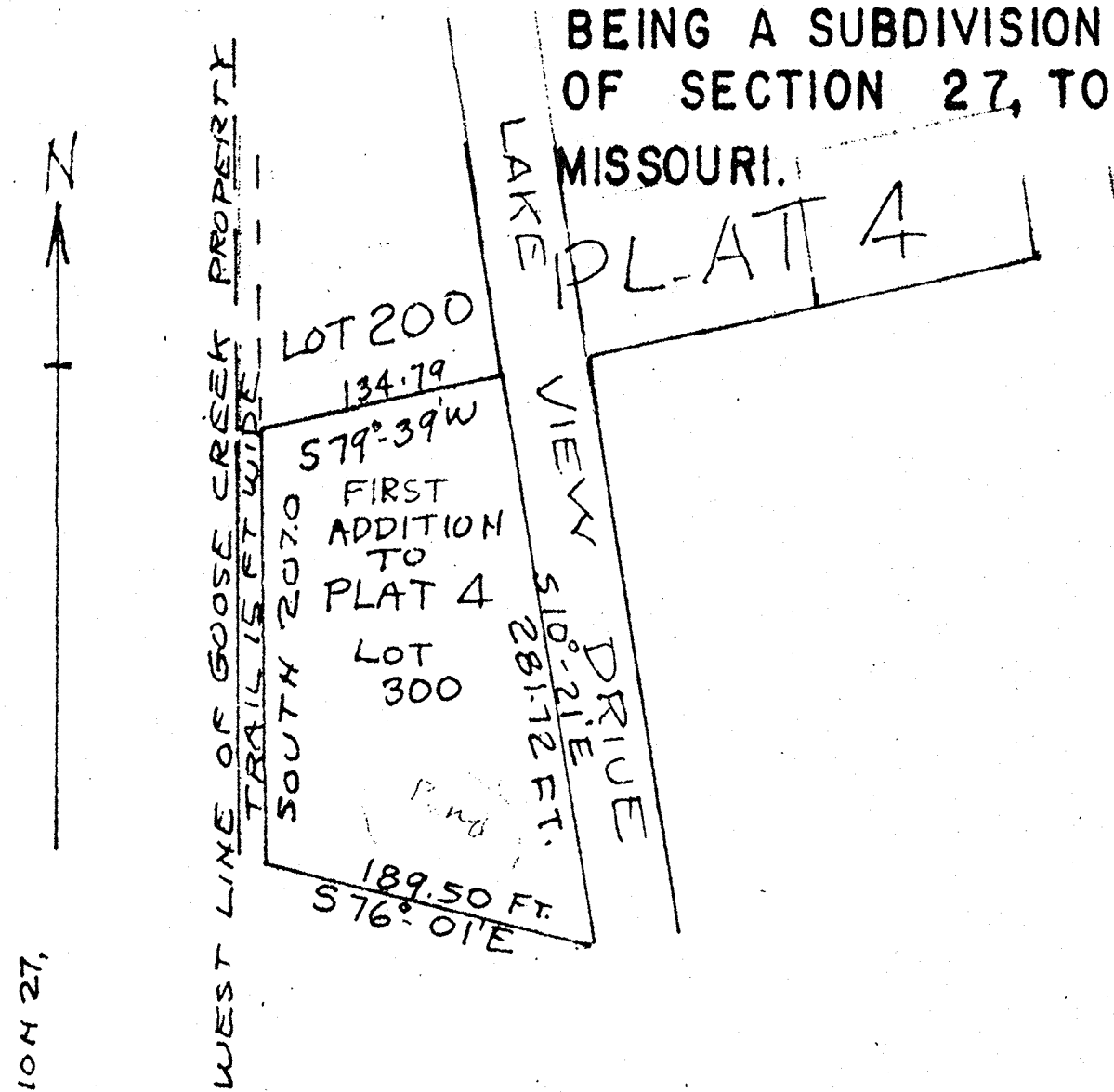


GOOSE CREEK SUBDIVISION- FIRST ADDITION TO PLAT 4

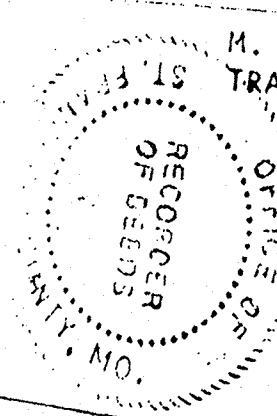
