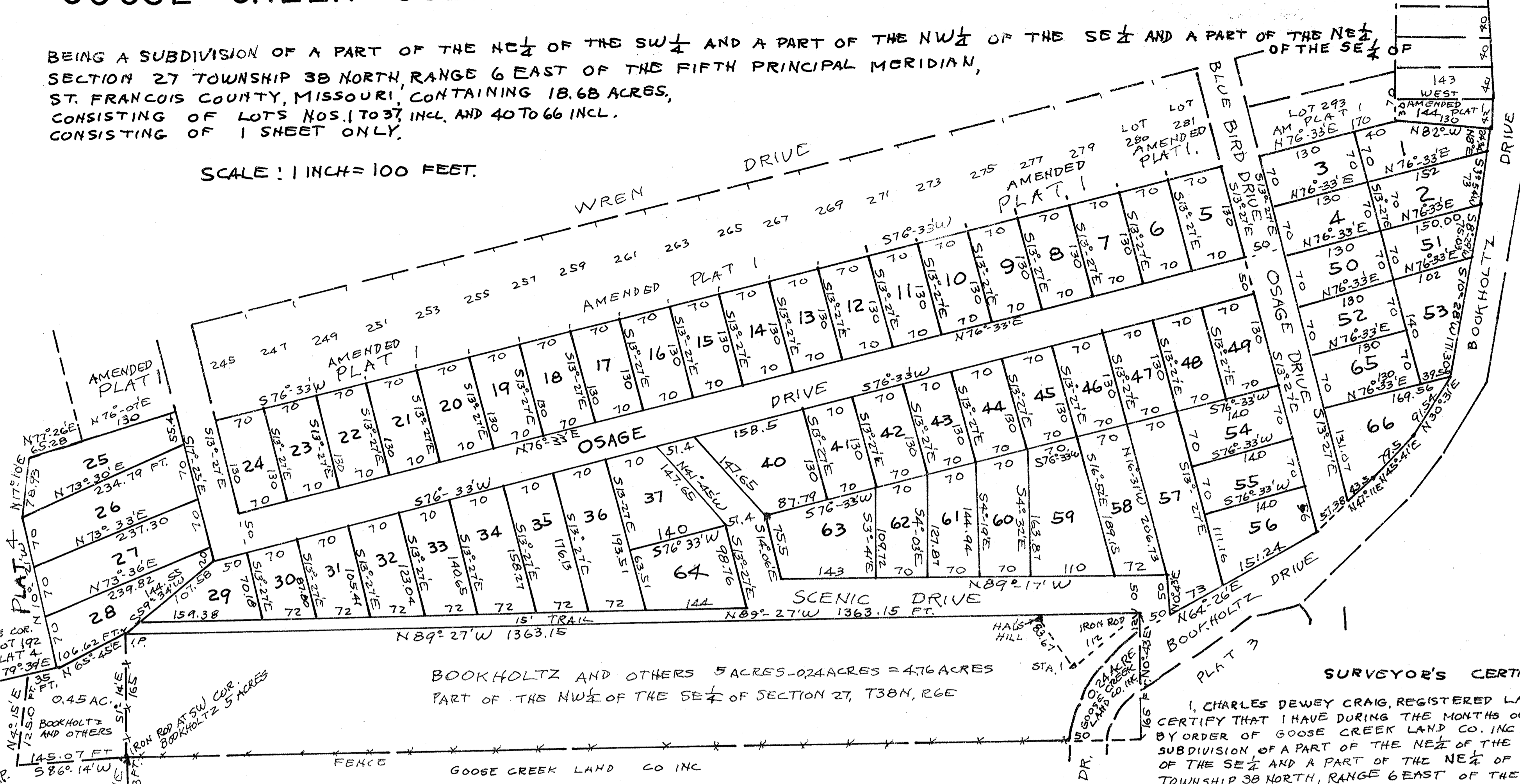


GOOSE CREEK SUBDIVISION - PLAT NO. 9

BEING A SUBDIVISION OF A PART OF THE NE 1/4 OF THE SW 1/4 AND A PART OF THE NW 1/4 OF THE SE 1/4 AND A PART OF THE NE 1/4 OF THE SE 1/4 OF SECTION 27 TOWNSHIP 38 NORTH, RANGE 6 EAST OF THE FIFTH PRINCIPAL MERIDIAN, ST. FRANCOIS COUNTY, MISSOURI, CONTAINING 18.68 ACRES, CONSISTING OF LOTS NOS. 1 TO 37, INCL. AND 40 TO 66 INCL. CONSISTING OF 1 SHEET ONLY.
